### **OLD BUSINESS**

# BSP CELL TOWER LEASE CONSULTING AGREEMENT

Mr. Ryan recused himself from the conversation. Mr. Austin questioned why the contract requires a five year commitment? He would prefer to enter into a one-time engagement with BSP for the renegotiation of the Verizon lease at Knolltop. Mr. Austin has contacted the references given and they all have had good experiences with BSP. Mr. Weiner and the Board expressed a number of questions regarding the language and terms of the contract. Mr. Weiner will send a letter with the board's questions and invite them back for next month's board meeting.
